#### 1) Eligibility Criteria for Firms:

- Registration of Ownership
- Registration under Service Tax
- Registration under Income Tax
- Registration under Sales Tax/ VAT
- Registration for issue of Food License by Department of Food and Drugs
- Experience certificate of providing such services in programmes organised by Government Department/institution/PSU's
- Restaurant should be situated within 5 kms from Vikas Bhawan.

#### 2) Documents to be enclosed:

- > Security Deposit of Rs. 10,000/- through Demand Draft/ pay Order or FDR in the name of Uttarakhand State Rural Livelihoods Mission, payable at Dehradun.

- Restaurant should have minimum turnover of Rs. 30 lakhs in each of the three previous financial years i.e., FY 2013-14, 2014-15 and 2015-16.
- Bills of the restaurant shall be paid on monthly basis after deducting TDS as per the rates applicable

- Restaurant has to submit an undertaking on Rs. 100/- non-judicial stamp paper that the firm is not blacklisted.
